NOTICE OF SEVENTY-FIFTH ANNUAL GENERAL MEETING, REMOTE E-VOTING AND BOOK CLOSURE

Notice is hereby given that Seventy-fifth Annual General Meeting ("AGM") of Abbott India Limited ("the Company") will be held on Thursday, August 22, 2019 at 3.30 p.m. at Y B Chavan Auditorium, General Jagannath Bhosale Marg, Mumbai 400 021, to transact the business as set out in the Notice, which has been dispatched to the Members along with the Annual Report for the financial year 2018-19, Remote E-voting Form, Proxy Form and Attendance Slip.

Notice is further given that pursuant to the provisions of Section 91 of the Companies Act, 2013 ("the Act") and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended from time to time, ("the Regulations"), the Register of Beneficial Owners, Register of Members and Share Transfer Books of the Company will remain closed from Friday, August 16, 2019 to Thursday, August 22, 2019 (both days inclusive).

Final dividend of ₹ 50/- and special dividend of ₹ 15/- per equity share for the year ended March 31, 2019, recommended by the Board of Directors, if approved by the Members at the ensuing AGM, will be paid on and from August 28, 2019 to the Members whose names appear on the Register of Members as on August 22, 2019 and to the Beneficial Owners of the shares as on August 15, 2019, as per the details furnished by the Depositories for this purpose.

As per Section 108 of the Act, read with Rule 20 of the Companies (Management and Administration) Rules, 2015, and Regulation 44 of the Regulations, the Company offers the remote e-voting facility to the Members to cast their votes by electronic means on all the resolutions set out in the Notice convening Seventy-fifth Annual General Meeting.

The facility for voting through Insta Poll shall be provided at the Meeting. Members attending the Meeting who have not cast their vote earlier by remote e-voting shall be entitled to vote at this Meeting. A Member can participate in the Meeting even after exercising his right to vote through remote e-voting but shall not be allowed to vote again at this Meeting.

The details required under the Act and Rules framed thereunder, are given below:

1. Annual Report for the financial year 2018-19 containing Notice convening the Seventy-fifth Annual General Meeting, remote e-voting form, proxy form and attendance slip has been dispatched/emailed (on the email ids registered with the Company/Depositories) to the Members on July 30, 2019. The aforesaid documents are also available on the website of the Company at www.abbott.co.in and on the website of Karvy Fintech Private Limited ("Karvy") at <https://evoting.karvy.com>
2. The Company has engaged the services of Karvy to provide electronic voting facility to the Members of the Company.
3. The remote e-voting facility will be available during the following voting period:

Commencement of Remote E-voting:	From 9 a.m. (IST) on Monday, August 19, 2019
End of Remote E-voting:	Upto 5 p.m. (IST) on Wednesday, August 21, 2019

The remote e-voting will not be allowed beyond the aforesaid date and time and the remote e-voting module shall be disabled by Karvy upon expiry of the aforesaid period.

4. The cut-off date for the purpose of remote e-voting and voting at the Annual General Meeting is August 15, 2019 ("cut-off date"). A person, whose name is recorded in the Register of Members or in the Register of Beneficial Owners maintained by the depositories as on the cut-off date only shall be entitled to avail the facility of remote e-voting as well as voting at the Annual General Meeting through Insta Poll.
5. The voting rights of Members shall be in proportion to their shares of the paid-up equity share capital of the Company as on the cut-off date.
6. In case of Members whose email ids are registered with the Company, user ID and password will be sent through email by Karvy. In case of Members receiving physical copy of Annual Report and other documents, user ID and password are provided in the remote e-voting form. In case Member is already registered with Karvy for remote e-voting, they can use their existing user ID and password for casting their vote.
7. Any person, who acquires shares of the Company and becomes a Member of the Company after the date of dispatch of the Notice and holding shares as of the cut-off date, may obtain the user ID and password by sending a request at einward.ris@karvy.com
8. The facility of voting through Insta Poll will be provided at the Annual General Meeting. Members attending the Meeting and who have not cast their vote earlier by remote e-voting shall be able to vote at the Meeting.
9. Member can participate in the Annual General Meeting even after exercising the right to vote through remote e-voting but shall not be allowed to vote again at the Meeting.
10. Once the vote on a resolution is cast by the Member by remote e-voting, he shall not be allowed to modify the same or cast vote again.
11. Mr. Talzoom M. Khumri, Practicing Company Secretary (Certificate of Practice No: 88) (Membership No: FCS 993) has been appointed as the Scrutinizer to scrutinize the e-voting process in a fair and transparent manner.
12. The Scrutinizer shall after the conclusion of voting at the Meeting, will count the votes cast at the Meeting and unblock the votes cast through remote e-voting in the presence of at least two witnesses, not in the employment of the Company and shall make, not later than forty-eight hours from the conclusion of the Annual General Meeting, a consolidated Scrutinizer's Report of the total votes cast in favour or against, if any, to the Chairman or a person authorized by him in writing, who shall countersign the same and declare the result of the voting forthwith.
13. The Results shall be declared by the Chairman or any other person authorized by him in writing on or within forty-eight hours from the conclusion of the Annual General Meeting. The results declared shall be along with the consolidated Report of the Scrutinizer be placed on the website of the Company i.e. www.abbott.co.in and on the website of Karvy i.e. <https://evoting.karvy.com> immediately after the declaration of results. The results shall simultaneously be forwarded to the BSE Limited, Mumbai.
14. Detailed process and manner of casting of votes are provided in the remote e-voting form annexed to the Notice of AGM sent to the Members along with Annual Report for the year 2018-19.
15. Subject to receipt of the requisite number of votes, the Resolutions shall be deemed to be passed on the date of the Annual General Meeting i.e. August 22, 2019.
